Designed by Graham Marsh and Ross Watson and first opened in 1990 the par 72 course measures 6,392 metres off the championship tees (with four tee spots on offer) and its ACR rating of 75 offers the first clue as to the scale of the challenge that awaits the keen golfer.

PLATINUM MEMBERSHIP TERMS AND CONDITIONS

1. Membership is valid for one person only and is not transferable
2. Membership fees are not refundable
3. Membership fees will be described in an annual Schedule of Fees. This schedule is available from the Golf Shop on request
4. Family membership is limited to no more than 2 (two) adult golfers related by marriage. Proof of relationship is required
5. Members are required to show their membership cards on request. Failure to produce proof of membership may result in the member being charged full green fees
6. Purchase of multiple years Membership in advance is not allowed. Memberships can be purchased for one year only
7. Paradise Palms Resort & Country Club reserves the right to revoke memberships for any legal reason.
8. Membership fees are payable in full, in advance or by quarterly instalments
9. Where the member chooses to pay their membership fees in quarterly instalments the following terms apply:
 - 9a. On acceptance by management of a signed application form the member is contracted to the full term of membership as detailed on the membership application form.
 - 9b. Quarterly fees are payable in advance
 - 9c. The member must supply a valid credit card, the expiry date of which must meet or exceed the full term of membership
 - 9d. Quarterly fees will be charged to the members credit card on the dates specified in the Schedule of Fees
 - 9e. Failure to make payment may result in cancellation of membership
 - 9f. Should a member wish to cancel their membership before the full term of expiry a cancellation fee of 50% of the outstanding amount of instalments shall apply
 - 9g. Where a member holds a current monthly account, instalment payments may be charged to this account (subject to account conditions)
10. Members may request their membership to be suspended for a maximum of 3 (three) months due to medical or personal reasons. This must be directed in writing to the Director of Golf. Each case will be assessed on a 'case by case' basis by management and a written outcome will be provided to the member. Management's decision on all cases shall be final
11. Platinum members are entitled to a 10% discount on Golf Shop merchandise, Beverage Cart and Fifty Nine Restaurant & Bar purchases. Gift Vouchers cannot be used in conjunction with platinum member discount purchases
12. Platinum members are entitled to a 30% discount on Accommodation at Paradise Palms Resort and Lakes Resort & Spa
13. Platinum members are entitled to a 10% discount the total bill at Rambutan Restaurant at the Lakes Resort & Spa

CART HIRE AGREEMENT

1. I understand that any loss or damage to the golf cart or hire equipment will incur an expense, which I will be required to pay immediately. This cost will be equal to the replacement or repair costs of the damaged item(s).
2. To accept full responsibility for all children who are passengers in the golf cart who are under the age of 17 years.
3. Only persons over the age of 17 yrs who hold a current valid drivers license will drive the cart. NB Learners Permit is not considered a drivers license.



4. There are no physical or psychological reasons why I should not be able to operate the Golf Equipment in a safe and responsible manner that will not cause damage to myself, other persons, or property and fixtures located at Paradise Palms Country Club.
5. To indemnify and to keep indemnified Paradise Palms Country Club, from all claims, damages, costs and expenses of any nature that may arise while the golf cart is under your control or any children under your supervision are at Paradise Palms Country Club
6. The Member represents that they are familiar with the operation, use and control of the golf cart, that they have read the instructions appearing on the golf cart, and that they are able to operate and control the golf cart in accordance with the instructions

MEMBER ACCOUNTS

Members may apply for a monthly account under the following conditions:

1. Account limit will be \$1000.00 unless alternative arrangements are made with Management
2. Account terms are 30 days from end of month
3. The member must supply a valid credit card, the expiry date of which must meet or exceed the full term of membership
4. Members shall receive monthly statements and itemized account listings
5. Members are required to show their membership card when charging to their account
6. Members are required to sign a copy of each individual account charge.
7. Members are responsible for obtaining a Tax Invoice/Receipt at the time of purchase/charge
8. Only the account holder may charge to an account
9. The primary account holder may authorize one other signatory
10. If a member's account does not comply with the account terms above, any or all of the following options may be applied:
 - 10a. the account may be suspended
 - 10b. the balance of the account may be charged to the credit card provided
 - 10c. Membership may be suspended or revoked

COURSE ACCESS

1. Members shall register for all rounds via the Pro Shop
2. Membership provides access to the course 7 days a week, subject to availability, except for events or competitions not sponsored by Paradise Palms Resort & Country Club as follows:
 - 2a. Platinum member privileges do not extend to events or competitions organized by external organizations or businesses except where the terms of that event require entrants to pay green fees directly to Paradise Palms Resort & Country Club.
 - 2b. Where an event cost includes charges for non green fee items, Platinum Members are required to pay the non green fee portion of the event entry.
3. The ability to book tee times will be limited to 2 (two) weeks in advance.
4. Failure to provide a minimum of 24 hours notice of cancellation of a tee booking may result in a cancellation fee of \$20 per person being charged.

CONDUCT

1. All members are required to abide by the following rules of conduct
2. Members are responsible for the behaviour of their guests
3. Members and their guests will at all times follow any reasonable direction given by a staff member of Paradise Palms Resort & Country Club
4. Offensive behaviour or abuse toward other members, members of the public or staff will not be tolerated at any time and may lead to cancellation of membership without notice or refund
5. Members shall at all times follow the rules and etiquette set down by the Royal & Ancient and the USGA
6. Members are obliged to report all breaches of the rules to management
